



## **Policy Statement**

At UnitedHealth Group Information Services Pvt. Ltd (UHGIS), social responsibility leverages the extraordinary abilities of our people, ideas and resources to help the communities where we live and work. We are committed to building healthier and better communities, and aligning our resources against this mission so that our community giving can be most effective.

In line with the provisions of Section 135 of the Companies Act, 2013, UHGIS envisages to annually spend two percent of the average net profits made by UHGIS during the three immediately preceding financial years of the Company towards Corporate Social Responsibility (CSR) initiatives.

# **UHGIS** will support projects in the following areas:

**Education** – Promotion of education by providing support to schools/ learning centers for underprivileged sections of the society through capacity building (e.g. salaries for teachers, transport), infrastructure support (e.g. teaching aids, electricity, water) and basic needs (e.g. stationary, meals, uniforms).

**Health care** – Providing health care support to people from underprivileged sections of society with a focus on women and children by increasing access to primary health care facilities, conducting preventive health care programs and medical support towards general illnesses.

**Disaster relief** – Providing relief and rehabilitation support to communities and individuals affected by natural calamities/ disasters.

## **Policy Details**

CSR committee of directors as required under Section 135 of the Companies Act, 2013 was constituted on July 21, 2014, comprising of Mr. Anurag Khosla (Chairman), Mr. Rajat Bansal and Mr. Partha Mishra.

As per the provisions of Section 135 of the Companies Act, 2013, UHGIS will allocate 2% of its average net profit before tax of the last three years for CSR projects. The total funds earmarked for CSR in FY 16 – 17 amounts to INR 3,70,00,000\* (\*estimated amount based on audited financials for FY 13-14, FY 14-15 and unaudited financials for FY 15-16).
